Starting from a brief consideration of the nature of professionalism we will take as a case study of quality assurance and enhancement in HE in the UK the development of programmes and accreditation processes for those who teach in HE. The changing nature of the profession of university lecturers will be discussed with particular reference to initial professional development and continuing professional development in teaching. You will be invited to share accounts of initial/continuing professional development opportunities and requirements for university staff in your own institution and national system with colleagues from other HEIs.
